In Honor of Dr. Daniel Duann

- WHEREAS, Dr. Daniel Duann worked in the Analytical Department of the Office of the Ohio Consumers' Counsel, beginning in 2008 and then as Assistant Analytical Director beginning in 2018 and then as Analytical Co-Director beginning in 2021, on behalf of Ohio's residential electric, natural gas, telephone, and water utility consumers; and
- WHEREAS, Dr. Daniel Duann joined the Ohio Consumers' Counsel from the National Regulatory Research Institute at The Ohio State University whose original Director, Professor Douglas Jones, taught regulation in the public interest to a number of Ohio Consumers' Counsel employees, including the current Agency Director, in classes at the University; and
- WHEREAS, Dr. Daniel Duann, during his career with the Ohio Consumers' Counsel, advanced the agency's mission to "advocate for Ohio residential utility consumers through representation and education in a variety of forums," including through his expert testimony in regulatory cases; and
- WHEREAS, Dr. Daniel Duann, during his career with the Ohio Consumers' Counsel, advanced the agency's vision for "informed consumers able to choose among a variety of affordable, quality utility services with options to control and customize their utility usage, including through his own advocacy and his mentoring of colleagues for their advocacy;" and
- WHEREAS, Dr. Daniel Duann performed his public service with distinction and according to the Ohio Consumers' Counsel's core values of justice, excellence, respect, communications, and integrity; and
- WHEREAS, Dr. Daniel Duann provided invaluable advice and counsel to the Consumers' Counsel and to the agency's staff for serving and protecting Ohio's residential utility consumers; and

- WHEREAS, Dr. Daniel Duann long advocated for preventing utilities from charging too-high profits to consumers and was a member of the Consumers' Counsel's case team that recently, with others, negotiated a settlement with FirstEnergy for it to refund and credit \$306 million to consumers; and
- WHEREAS, The Governing Board of the Ohio Consumers' Counsel, in concert with the Agency Director and the Deputy, would like to publicly acknowledge the many contributions of Dr. Daniel Duann to advocacy for Ohio consumers and for the Office of the Ohio Consumers' Counsel; and
- THEREFORE BE IT RESOLVED that the Governing Board of the Ohio Consumers'
 Counsel commends Dr. Daniel Duann for his public service to Ohio's
 residential utility consumers, to the Governing Board and to the Office of
 the Ohio Consumers' Counsel; and
